This letter has been authorized to set forth the general rules for maintaining an orderly operation of the cemetery.

Rule 1. There shall be no unauthorized cutting or pruning of trees within the confines of the cemetery. If there is a problem, it should be brought before the Administrative Board for discussion and dissolution.

Rule 2. A permanent type of grave marker should be installed within six months of an interment. Temporary markers may be inadvertently damaged by mowing equipment or removed and/or destroyed by vandals.

## BETHEL BULLETIN TRUSTEES

The Board of Trustees met September 6th and approved changes in Restrictions and Guidelines for Bethel Cemetery. These proposals were adopted by the Administrative Council on September 10, 1995. Under the new guidelines the purchase of grave sites is limited to those persons who are full members of Bethel UMC as of October 1, 1995, and to their spouse and their first generation children. Those members who qualify shall have until October 1, 1996 to purchase a grave site. After October 1, 1996 the cemetery shall be deemed closed as to the purchase of grave sites. The Trustees also provided for exceptions to these guidelines and grave sites already purchased are not effected by these changes. You may contact the Church Office to receive a complete copy of the guidelines.

In other action taken by the Trustees and approved by the Council, a fee of \$75 was set for the use of the sanctuary for weddings by non-members. An additional fee of \$75 was set for the use of the fellowship hall for non-member wedding receptions. The Trustees reaffirmed the policy of allowing neighborhood and civic groups to use the Fellowship Hall, with no fee, provided the group clean the hall after their use. The Trustees also restricted the use of church property, such as tables and chairs, to church members.
